ASSUMPTION OF RISK: I am aware that the sport of Dogsledding has inherent risks. The nature and extent of these risks include, but are not limited to:

AVALANCHES: Any injury or death resulting from an avalanche; which may occur in the mountain terrain used for dogsledding. TERRAIN: Any manner or injury resulting from falls on bridges, cliffs, creeks, and icy or uneven terrain.

WEATHER: Any injury or illness resulting from the elements such as but not limited to frostbite, exposure, hypothermia, etc.

WILD AND DOMESTIC ANIMALS: Including curious or aggressive wildlife: moose, bears, rodents, birds, Giardia parasite, or other non-domestic animals or parasites, as well as injury incurred by our dogs behavior, dog bites, our dogs in general, and other domestic animals.

EQUIPMENT: Any manner or injury resulting from use, misuse, non-use and failure of any equipment.

THE OPERATOR AND OTHER PARTICIPANTS: The conduct, including negligence of the operator, tour conductor and of other participants. This includes Dogsledding under the control of tour conductors, whose advice and direction may differ from Dogsledding practices elsewhere. As well but not limited to, the risks and transmission of COVID-19 between persons.

HAZARDS OF TRAVEL: There is a possibility of sudden impact terrain features that can result in bodily injury or death. Injury may be caused by but not limited to: Making contact with trees rocks obstructions and other participants, visible or non-visible.

COVID-19: The risk of exposure to COVID-19, when travelling, being in close contact with other individuals, and or visiting any public location, regardless of the Operator's safety plan and protocols that have been implemented.

of dogsledding, prediction of avalanche danger, prediction or weather conditions, or any other conditions or factors that may amount to a departure to the standard of care which a person of common prudence usually takes of his own concerns having regard for the activity of dogsledding.
